



# HONG KONG PROFESSIONAL BOXING BOARD

## Guidelines for License Applications

The Hong Kong Professional Boxing Board (HKPBB), the governing authority for professional boxing in Hong Kong, mandates that all Professional Boxers, Trainers/Assistant Trainers, Promoters, and Gyms participating in HKPBB-sanctioned events hold a valid license issued by the HKPBB. This notice outlines the application process, requirements, fees, and delivery options for obtaining a Professional Boxer License, Trainer/Assistant Trainer License, Promoter License, or Gym License.

### General Licensing Requirements

#### 1. Eligibility:

Participation in HKPBB-sanctioned events requires a valid HKPBB-issued license for Professional Boxers, Trainers/Assistant Trainers, Promoters, and Gyms.

#### 2. Validity:

Licenses are valid for one year (12 calendar months) from the date of issuance and must be renewed annually.

#### 3. HKPBB Authority:

The HKPBB reserves the sole right to grant, deny, or suspend a license at its discretion, including in cases of misconduct by a license holder.

#### 4. Confidentiality:

All personal information provided during the application process will be treated with strict confidence and used solely for license application, issuance, and, for Professional Boxers, registration with BoxRec.

### Application Process

#### 1. Professional Boxer License

To obtain a Professional Boxer License, applicants must:

- Submit:
- Completed Professional Boxer License application form.
- One recent passport-sized photograph.
- A copy of a valid Hong Kong SAR Identity Card or passport.
- Payment of the non-refundable license fee of HKD 1,200.

## **Mandatory Medical Examination**

Applicants must undergo a medical examination at the HKPBB-recommended medical center at a fixed cost of HKD 2,450, payable directly to the medical center on the day of examination. The examination must be completed within 7 days of application submission, and the medical report must be up-to-date.

The examination includes:

- Computer Tomography (CT) scan of the brain (plain).
- Blood screening tests for:
  - Hepatitis B Surface Antibody (HBsAB).
  - Hepatitis B Surface Antigen (HBsAG).
  - Hepatitis C Virus Antibody (HCVAb).
  - HIV 1 & 2 Antibodies and p23 Antigen.

Upon receipt of the completed application form, supporting documents, and proof of license fee payment, the HKPBB will issue a referral letter enabling the applicant to schedule a medical examination appointment at the recommended medical center. Applicants must consent to the release of test and scan results to the HKPBB for consideration.

## **Processing**

Applicants will be notified of the result within one month of submission.

## **2. Trainer/Assistant Trainer License**

To obtain a Trainer/Assistant Trainer License, applicants must:

- Submit:
  - Completed Trainer/Assistant Trainer License application form.
  - One recent passport-sized photograph.
  - A copy of a valid Hong Kong SAR Identity Card or passport.
  - Payment of the non-refundable license fee of HKD 800.

## **Processing**

Applicants will be notified of the result within one month of submission.

## **3. Promoter License**

To obtain a Promoter License, applicants must:

- Submit:
  - Completed Promoter License application form.
  - One recent passport-sized photograph.
  - A copy of a valid Hong Kong SAR Identity Card or passport.
  - Payment of the non-refundable license fee of HKD 20,000.

## **Processing**

Applicants will be notified of the result within one month of submission.

#### **4. Gym License**

To obtain a Gym License, applicants must:

- Submit:
- Completed Gym License application form.
- A copy of a valid Business Registration (BR) certificate.
- Payment of the non-refundable license fee of HKD 1,000.

#### **Processing**

Applicants will be notified of the result within one month of submission.

#### **License Fees**

The following fees apply for HKPBB licenses and related services:

- Professional Boxer License: HKD 1,200
- Trainer/Assistant Trainer License: HKD 800
- Promoter License: HKD 20,000
- Gym License: HKD 1,000
- Approval Letter (per fight): HKD 200

#### **Notes:**

- License fees are non-refundable once approval has been granted.
- If an application is declined, the HKPBB will issue a full refund of the license fee within seven working days.
- The medical examination fee (HKD 2,450) for Professional Boxers is payable directly to the recommended medical center.

#### **License Card Delivery**

Upon approval and printing of the license card, applicants may choose one of the following delivery options:

- SF Express Delivery: Applicants may pay an additional delivery fee (to be confirmed by HKPBB) for delivery via SF Express.
- Local Post: If no delivery fee is paid, the license card will be sent via standard local post.
